- *✔ T4 (Employment income)
- *✔ T3, T5, T5008 (Interest, dividends, mutual funds)
- *✔ T4E (Employment insurance benefits)
- *✔ T4A(P), T4A(OAS), T4A (Old Age Security and CPP benefits)
- *✔ T4A (Other pensions and annuities)
- *✔ T4RIF (Statement of income from Registered Retirement Income Fund)
- *✔ T4RSP (How much money you withdrew from or received out of your RRSPs and how much tax was deducted Also shows money withdrawn from an RRSP under Ho Buyer's Plan and amounts transferred an RRSP to a spouse or partner under a court judgment or written agreement)
- *✔ T5007 (Social assistance payments/ Workers' compensation benefits)
- *✔ RRSP contribution slip
- *✔ T2202A (Tuition / education receipts)
